July 3, 2019

1. Opening. Mike Mokri called the meeting to order at 5:00PM on July 3, 2019. Mike indicated he would be leading the meeting, due to Wayne Silva being under the weather.

2. Agenda.

- A. Meal.
- B. Club Financial Review Bob Brown read the financial report.
- **C.** Mike noted that club dues for 2019 remained at \$10 and noted to keep the due low, volunteers will be needed for the two Vendor's Fairs each year. Request for will go out the end of July or first of August.
- D. Review of top 5 teams and top 5 players from the Spring session. Top 5 teams were: 5th place, Team LoPresti; 4th place, Team Mataski; 3rd place, Team Stuhler; 2nd place, Team Skrabak and 1st place Team Warren. Top 5 players were: 5th place, Ron Jackson; 4th place, Chan Nevin; 3rd place, Wayne Casey; 2nd place, Ed Roney and 1st place, Blain Harvey.
- **E.** Acknowledgement of players who shot 40's. Total of 26 guys shot 40s, total of 42 perfect matches. Blain Harvey had 4 perfect matches and John LoPresti and Ed Roney shot 3 perfect matches during the session!
- F. Introduction of new club members. Mike introduced; Dan Jennings.
- **G.** Mike reminded everyone that if they had any questions about local rules, such as the rules governing subs, the local rules are available for all to see on the website under the "Miscellaneous" tab.
- **H.** The local rule covering the number of times a member can play in a week was also discussed. Members were reminded that you are only allowed to play two matches each week. That means they can play one regular match and sub once **or** sub twice in a week. The two matches they play can come any time during the week, including playing twice in one day.
- I. Mike indicated that the CAC team was looking at changing the rules to limit the number of terms for club officers. After discussing, Mike pointed out that as a club, we voted recently to keep the sub rules as they are. Members were given 2 options about the use of subs in January, 2019. The first option was to keep the rules for subs as they are. The second option was to eliminate any consideration of handicaps when selecting a sub. By a margin of one vote, the club voted to keep the rules for subs as they are.
